1A Paul Krismer - Being a Safety Superstar: Integrity First

Many senior leaders, front-line supervisors, safety officers, and union representatives come to their roles as a function of their expertise in a specific subject matter, but leadership requires much more than job-specific skills. This talk de-emphasizes what we individually know and instead asks us who we are. Find out how corporate cultures are open to positive change. Leverage positive psychology to bring creativity, reduced disability, and superior safety outcomes in your workplace. Men and women who influence the behavior of staff can learn a mindset that shifts them from overseers of business processes to genuine leaders—seeing the big picture, articulating the direction, and embracing their team in a collaborative and committed mission. Transformative organizational change occurs when leaders are coaches who operate with emotional intelligence and profound personal integrity. Safety really can be "Job One"!

1B Claire Moccock MBA, BSc, Cert. OHS - "Culture change is hard! ... does it have to be?"

While using traditional definitions of organizational and safety culture, Claire debunks the myth that changing an organization's culture is "too difficult". Claire works with conference participants to paint a picture of what a positive safety culture would look like in their organization and completes a case study on some of Canada's leading safety culture companies. Participants are then walked through the different techniques of motivating workers and employers to prioritize safety activities in the workplace. Claire breaks down key activities that she has used and witnessed with

and within success in change management, communication and improving an organization's safety culture. It is not the activity that improves the culture, it is the approach taken with the activity in regards to planning, implementing and educating safety systems and initiatives in the workplace. Claire explains that these activities and approaches must be specific to the needs of the organization, while complementing and reinforcing current business processes.

2A Glen Sollars - Creating a Culture of Feedback in Safety

Following safety procedures and recommendations is critical and therefore needs to be addressed – not always easy. How do you create a work environment where employees hold each other accountable in being safe and not relying on the boss to always do so? You will learn how to create a culture of feedback through tools that make it easier to provide feedback in a way that will increase the chance of lasting behavioral change.

2B Claire Moccock - Before and After a Workplace Injury

This 1.5 hr. session is designed in two parts, part 1 walks conference participants through a theoretical first aid assessment. Claire then explains that the first aid assessment identifies prescriptive requirements that are needed at your workplace for first aid attendants, supplies, rooms and transport. Claire navigates participants through the OHS Regulation Schedule 3-A: Minimum Levels of First Aid – how to use it and what you need to know. The second part of this 1.5 hr session, outlines the process that is required following a workplace injury. Claire explains requirements for first aid reporting, immediate notifications to WorkSafeBC, incident investigation (preliminary and full) as well as claims management forms and processes. Claire clearly communicates to conference participants what their responsibilities are to demonstrate due diligence. Claire has observed that organizations can struggle with navigating through these regulations, insurance, forms and

3A Dr. Tanya Flood FYI Doctors - Proper Protection Equals Eye Injury Prevention

Participants will join a hands-on interactive course to discover the latest eye protection for the job, changes in technology related to our eyes and important WorkSafe BC Statistics.

Eye injuries are one of the most common non-fatal injuries in the workplace and as many as 90% can be prevented. Participants will explore and experiment with various eye wear options to discover specific solutions for their industry. Additionally, participants will learn about common diseases, disorders, injury prevention and outcomes to help enlighten, educate and protect their teams on the job.

3B Terry Duncan "Human Nature" – A walk trip, slip, sprain, strain, fall, through history

A discussion regarding foolish things human beings do using videos and photos. A light-hearted look at some serious situations. Terry will question participants about what they see and how they would respond. There will be ample opportunity to reflect on the scenarios.

3C Glen Sollars - Influencing a Safety Culture

Nobody likes change or being told what to do. How does one overcome resistance? Learn how to influence employees effectively by focusing on what's important to them. Advocate more powerfully through story telling, structuring communication in a logical way and being authentic; all in a way to optimize buy-in and reduce conflict.

The Ten Influencing Factors for Risk Tolerance

A presentation on the break through research on risk acceptance complete with approaches on how to identify and address the influencing factors in the work place. Three variations on the topic - one for senior management and executives, one for safety professionals and one for front line workers. The study of why we accept risk reveals a multitude of intrinsic and extrinsic factors that impact the decisions of individual workers and groups of workers. All of these influencers have been grouped into 10 key categories.

- Overestimating Capability or Experience
- Familiarity with the Task (or Complacency)
- Seriousness of Outcome
- Voluntary Actions and Being in Control
- Personal Experience with a Serious Outcome
- Cost of Non-Compliance
- Over Confidence in the Equipment
- Over Confidence in Protection and Rescue
- Potential Profit & Gain from Actions
- Role Models Accepting Risk

4A Dave Fennel - Beyond Swiss Cheese and Equilateral Triangles

It is 2019 and it is time for Safety Professionals to do some critical thinking on how we use the traditional safety models that have guided our approaches to safety in the past. This topic will explore some traditional safety models to see if they still apply in 2019. Are they still accurate? And how can we use them to influence our management, our workers and our clients to improve their safety? Dave will show us how we can upgrade these safety models to make them more applicable in 2019 and beyond. The good old incident triangle and the Swiss cheese model will be examined and Dave will encourage a new mind set from safety people on how to use critical thinking on these and other safety issues.

4B Cody King & Jessie Kunce - WorkSafeBC's 2018-2020 Marine Safety Initiative

The Marine Initiative was developed to address the high number of serious injuries and work-related deaths in commercial fishing, but also expands into other marine industries such as commercial sports

fishing, Aquaculture, tug and barge, and ecotourism. The Marine Initiative utilizes a risk-based, two-tiered inspectional approach for commercial fishing with a provisional focus on other marine activities. Priority focus will be on the highest risk fisheries such as Longline/Trap, Trawl, Seine, and Dive Fishing/Commercial Diving. Our primary goal is to reduce serious injuries and fatalities in the marine sector while working with industry to provide vessel owners, masters and crews with information and resources pertaining to safety on fishing vessels.

4C Kelsi Baine - The Mental Health Support Network-Navigating the pipelines to get the help you need

Sometimes navigating the right route to get the help you need can feel confusing and daunting. And sometimes it really is. When you aren't feeling well, suffering with stress, depression, anxiety, conflict, loss, or many other different issues – the last thing you need is to feel overwhelmed and confused about what to do and where to turn. Gaining clarity around these and other questions can alleviate stress and expedite the process of getting the help you need. The more we all understand about these and other resources and how to access them, the more we strengthen both our personal and work safety culture through education, awareness, and prevention efforts.

5A Helen Chandler - New Worker Training & Orientation - Moving Beyond the Checklist

Did you know that nearly one-third of time-loss injuries are suffered by workers with less than one year of service? Or that more than half of all serious injuries occur during the first six months of employment? Providing effective new and young worker training is key to reducing workplace injuries, increasing productivity, and ensuring working participation in your health and safety program.

COURSE: **BC HYDRO - ELECTRICAL SAFETY TRAINING FOR MUNICIPAL AND TRADES WORKER**

This course is offered twice. Please choose between either of these two separate sessions.

Session **8:30 - 10:30am** **\$100.00**

Course Description:

Learn the basics of how electricity behaves and how to spot overhead and underground hazards. Find out how to plan your work and carry it out in a safe manner. Discover what to do if your equipment contacts a power line. Learn how to meet WorkSafeBC requirements for working near high-voltage lines.

By the end of this training, participants will be able to:

- Describe the basics of electricity and BC Hydro's power system
- Identify the hazards of working around overhead and underground power lines
- Explain how to plan and conduct your work when working on or near the electrical system
- Describe what action you need to take if:
 - Your equipment contacts a power line
 - You are working around a downed power line
 - You need to escape from an energized area

The purpose of this training is to teach trades workers about electricity, how to recognize electrical hazards, and what to do if they, or their colleagues, make contact with electrical infrastructure or need to escape from an energized area.

COURSE: **BC FOREST SAFETY COUNCIL - JHSC FUNDAMENTALS** (lunch included)

Full Day **8:30am - 4:30pm** **\$325**

This course meets the training requirement for new joint committee members and / or worker health and safety representatives, as outlined in section 3.27 of the Occupational Health and Safety Regulation.

Learning Outcomes:

1. Explain the purposes of and refer to the Act, the Regulation, and the Guidelines as they relate to Joint Health and Safety Committees (JHSCs).
2. Describe the composition, role, authority, and responsibilities of a Joint Health and Safety Committee.
3. Follow JHSC terms of reference to carry out the work of the committee, including: identifying unsafe situations, addressing workers' concerns about safety, making recommendations for improvements, and understanding the annual requirement for a JHSC evaluation.

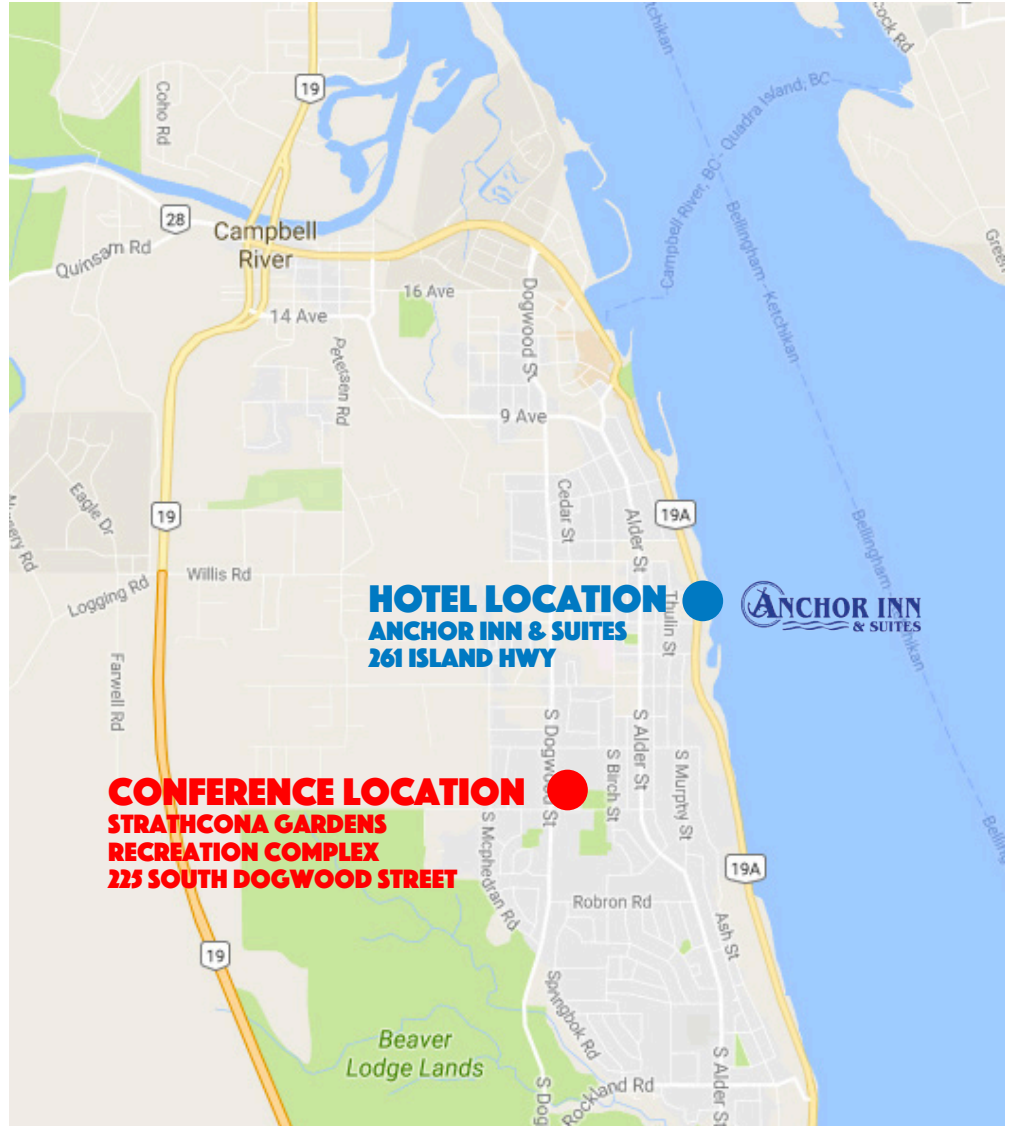

CAMPBELL RIVER MAP:

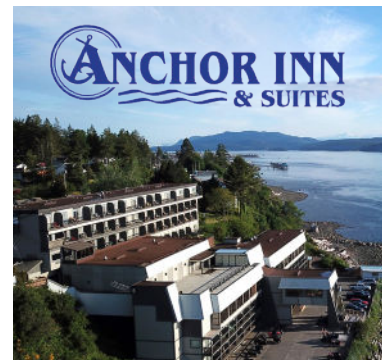
