EXHIBITOR AGREEMENT

PLEASE NOTE: NO REFUNDS FOR CANCELLED REGISTRATIONS AFTER MARCH 20, 2026.

1. All exhibitor spaces are supplied with Power, WIFI, Security and the following:

8X10 Booth 8ft High drapery back wall 10x10 Booth 8ft High drapery back wall

3ft High drapery side walls 3ft High drapery side walls

All spaces have a maximum door entry of 11' H x 10' W.

- 2. Applications will not be processed unless all monies are received. All monies paid after acceptance of this application are nonrefundable after March 20, 2026.
- NIOAS staff reserves the right to cancel/postpone the show outright in cases or circumstances beyond the control of NIOAS staff & the Strathcona Regional District. In the event of show cancellation, all exhibitors registration fee will be refunded.
- 4. NIOAS staff reserves the right to move exhibitors booth locations for the overall benefit of the show.
- 5. Exhibitors shall abide by and observe all laws, rules, and regulations of the Province and City where the show takes place, and departments there of and all rules of the related facility.
- 6. Subletting of space by the exhibitor is prohibited. Sharing or other use of the space not specifically authorized prior to the show by the NIOAS staff is prohibited. Exhibitor agrees to promote only the business(es) registered for and approved by NIOAS staff.
- No signs or advertising devices shall be displayed outside space unless approved by NIOAS staff prior to the start of the show.
 Blocking the unobstructed view from space to space is prohibited. No displays or signs may be higher than your drapes without NIOAS staff approval.
- 8. No wiring, installation of spotlights/electrical work or carpentry work permitted. All alterations should be preformed by Regional District employees or firms designated by NIOAS staff.
- 9. The use of food machines and other accessories must be approved by NIOAS staff to ensure that services offered are not taking away from the facility Concession stand.
- 10. No exhibitor shall use any inflammable decorations or covering for display fixtures and all fabrics or other material used for decoration or covering of tables and/or risers shall be flameproof.
- 11. NIOAS staff are entitled to close an exhibit at any time for failure by any exhibitor or any of their officers, agents, or employees to perform, meet, or observe any term or condition set forth herein, and such exhibitor shall not be entitled to a refund.
- 12. NIOAS staff reserves the right to alter or change the space assigned to an exhibitor, to alter or remove exhibits or any part thereof, including printed materials, product, signs, lights, or sound, and to expel exhibitors or their personnel if their conduct or presentation is objectionable to other Show Participants.
- 13. The Strathcona Regional District carries a liability insurance policy and provides security of exhibits outside of show hours, however the Strathcona Regional District will not assume any responsibility for the safety of exhibits against theft, robbery, fire, accidents, or other incidents. In all cases, exhibitors are encouraged to insure their products (personal and exhibits) against any such loss.
- 14. PLEASE NOTE: The Strathcona Gardens Recreation Complex is currently undergoing an Aquatic & Wellness Centre construction project which will have no disruptions to the arena facilities where the NI Outdoor Show will be hosted. Additional entrances & signage will be in place for the weekend of the show to ensure a smooth and enjoyable experience for everyone.
